The Data Protection Authority of Sri Lanka (DPA), established under the Personal Data Protection Act No. 9 of 2022, is now establishing its high-standard Secretariat. We are looking for operational support staff to assist and facilitate the discharging of duties by the managerial staff of the Authority. Applications are invited from Sri Lankan citizens for the following post.

POST OF ASSOCIATE OFFICER (TECHNICAL) – INFORMATION TECHNOLOGY

Area of Key Responsibilities

- Oversee the design, implementation, and maintenance of the organization's technology infrastructure.
- Collaborate with the Information Technology Executive to align technology initiatives
- Setting up systems to ensure the availability, security, and performance of key digital infrastructure, other IT systems
- Support related procurements and contract management.
- Taking measures to set up and operationalize the IT helpdesk
- Assist in conducting IT training programs/sessions to enhance the technology literacy of the staff.

Qualifications and Experience:

The candidate should have following qualifications;

- A Bachelor's Degree recognized by the University Grant Commission (UGC) in Sri Lanka in Information Technology, Computer Science, Computer Engineering, Data Science, Cyber-security, Data Processing Management, or any other Degree relevant to the post, and awarded by a university, recognized by the UGC of Sri Lanka

With

At least two (02) years of experience in a corporation, statutory board, or a reputed private institution in relevant field

Age: Age should be not less than 22 years and not more than 45 years.

Remuneration and Benefits:

All-inclusive monthly salary of Rs 59,300/- as concurred by the Minister of Finance

REMUNERATION AND BENEFITS:

- Fixed-term contract initially for a period of three (03) years with entitlement to Employees' Provident Fund (EPF) and Employees' Trust Fund (ETF).
- An attractive remuneration package along with other benefits, enjoyed by the fixed term employees of the Authority

OTHER REQUIREMENTS:

- a) Should be a citizen of Sri Lanka.
- b) Should be physically and mentally fit to discharge the duties of the post well and to serve in any part of the Island.
- c) Should be of excellent moral character.
- d) Should have a good command of the English language as interactions with international agencies and other institutions overseas is a job requirement for professional grades.
- e) Familiarity with the digital economy and social media will provide an advantage.

GENERAL CONDITIONS

Age: limit will not apply to applicants from public corporation, statutory board, fully government owned company

Method of Selection – Suitable candidate will be selected based on one or more interviews. Appointments will be made purely in order of merit.

Closing Date for Applications – 18th May 2026

Secondment: Any eligible officer in public service seeking secondment to this position is responsible for coordinating with their line Ministry to release him/her from the service on secondment basis under the prevailing provisions specified by the Ministries in charge of Public Administration, Finance and other authorities. They should submit their applications through the Heads of the respective Ministries/ Departments/ institutions.

The secondment period is initially for one (01) year, and the renewals will be subject to the job holder's performance and other organizational requirements.
